





At meeting of Special Committee 3-20-63 it was proposed that the Committee's policy statement of 5-24-61 be amended to reduce paper work.

DATE: 3-27-63

The policy statement provided that on January 1 and July 1 of each year the member agencies would submit to the Special Committee reports on all research and development projects initiated subsequent to the last reporting date. Also, on April 1 and October 1 of each year, the member agencies would report on countermeasure equipment accepted for use by the respective agencies, as well as any modifications made by the reporting agencies in equipment in use.

It was proposed that the reports on research and development projects and on equipment in use, as well as modifications thereof, be combined. The combined reports would be submitted March 1 and September 1 of each year with the proviso that there will be continuous coordination of research and development projects, by the member agencies through their representatives on the Technical Subcommittee of the Special Committee.

It was proposed that the first combined report be submitted September 1, 1963. The report due in April, 1963, on equipment in use would be submitted as usual, but the research and development report due July 1 would not be submitted separately and the data heretofore submitted at that time would be included in the combined report due September 1.

The other member agencies have concurred in the proposed procedure, and it does not appear objectionable from the Bureau's b6 b7C standpoint.

The Technical Subcommittee (TS) of the above Special Committee on Technical Surveillance Countermeasures (SC) has drafted a report for the SC which was distributed to SC members at the last meeting. Although its contents were coordinated at the TS level, the final wording was determined at the TS meeting on 4/2/63.

The attached draft containing some highly technical sections and phraseology is to be used as the basis for the preparation of a non-technical annual report to the National Security Council and appended thereto. It has been carefully reviewed in the Laboratory and certain minor changes in phraseology as set forth in the attachment should be made to prevent any misconception of Bureau acceptance of the draft.

In general, it must be noted that the draft is the combined result of consideration by technical representatives of the State Department, the military agencies, Central Intelligence Agency (CIA) and the Bureau. State, CIA and the military having establishments abroad, some of which are surrounded by a hostile environment, are faced with a relatively difficult physical and technical problem of protecting those establishments from penetration by technical surveillances of foreign Governments. The major emphasis of the draft is therefore related to these most <u>difficult</u> environments. The Introduction (page 2) is very general;



Russians are buggy about bugs. They hide listening devices in mattresses, under flowerpots, behind wallpaper. Three years ago, they even bugged the eagle's beak in the Great Seal of the U.S. that hung in the American embassy in Moscow. It is all part of the espionage game, and looking for hidden mikes is considered high good sport by Americans in Russia.

But last week came word of a new Soviet bug—a really non-cricket one. A U.S. military attaché met a diplomatic source in a Moscow bar, ordered a martini, then engaged his companion in deep conversation. The waiter brought the drinks ordered—including an extra martini, which he set on a nearby fireplace mantle. The attaché finished his first drink in a few minutes, but then he couldn't locate the waiter to order another. Thirstily, he picked up the martini from the mantle, took a sip, then bit into the olive—ouch.

That was no olive—it was an olivecolored, plastic voice transmitter; its "toothpick" was really an antenna. The attaché was appalled—not so much at the device itself, but at its location: "If the damned thing can work under gin," he gasped, "it can work anywhere."
