This letter responds to your recent Freedom of Information Act ("FOIA") request received by the Federal Communications Commission (FCC or Commission) and assigned to the Consumer & Governmental Affairs ("CGB") and Enforcement ("EB") Bureaus. You request seeks copies "of all informal complaints received at the FCC regarding National Public Radio [b]etween January 2003 and the present." Please be advised that CGB only keeps it records for three years. Therefore, we would not have any responsive records from January 2003 to January 1, 2008.

CGB conducted a search of the databases in which we maintain the records of informal complaints filed by, or on behalf of, consumers. Our search revealed 76 documents that are responsive to your request, which are enclosed. EB informed CGB that a search of its records identified no responsive documents.

Mike Hennigan of my staff redacted all personal identifying information relating to the individuals who submitted or are named in the enclosed complaints or inquiries based on Exemption 6 of FOIA, which permits agencies not to disclose files that would clearly invade personal privacy.¹ Mr. Hennigan also redacted some FCC employee names based on Exemption 2 of FOIA, which permits agencies not to disclose internal personnel rules and practices.²

Please be advised that the Commission receives many complaints and comments that do not involve violations of the Communications Act or any FCC rule or order. Thus, the existence of a complaint filed against a particular carrier or business entity does not necessarily indicate any wrongdoing by any individuals or business entities named in the complaint.

FOIA and FCC rules require the FCC to charge requesters for time spent searching for and reviewing responsive documents, and for copying them.³ Based on your classification as an "all other" requester, the FCC does not charge you for the first two

hours of search time and the first 100 pages of copying.⁴ Because preparing the response to your request falls within these limits, the FCC is not charging you for processing it.

If you think this response denies your FOIA request, you may file an application for review of this decision with the FCC's Office of the General Counsel within 30 days.⁵ Both the application and envelope containing it must be marked "Review of Freedom of Information Action" and the application should refer to FOIA Control No. 2012-440.

And we begin this hour with the story of a single Marine unit. They call themselves Darkhorse. The 3rd Battalion, 5th Marine Regiment - nearly 1,000 enlisted men and officers - deployed to Afghanistan one year ago. By the time their seven-month tour ended, they had suffered the highest casualty rate of any Marine unit in the entire war.

Talk to the Marines of the Darkhorse Battalion now, and you hear the same thing: It was worth it. But talk to their wives and families, and you hear a more complicated story. All this week, we'll be telling the story of the Darkhorse Battalion, both at war and on the home front.

We begin today with NPR's Tom Bowman. First, a word of warning: This story contains strong language.

(SOUNDBITE OF GUNSHOTS)

TOM BOWMAN: These are the sounds of Sangin, in southern Afghanistan. The Marines learned the place fast. They

slogged through canals, fought through dense vegetation, and patrolled a maze of narrow, dirt roads bordered by 15-foot mud walls. It was October one year ago. The Marines who served there remember Sangin as different from anywhere else they've fought. Listen to how three of them describe the place. Sergeant

Sergeant DANIEL ROBERT: Hell.

BOWMAN: Lance Corporal Jake Romo.

Lance Corporal JAKE ROMO: The Wild West.

BOWMAN: Lieutenant Colonel Jason Morris.

Lieutenant Colonel JASON MORRIS: Dangerous. I've heard it described as the most dangerous place in Afghanistan.

BOWMAN: Colonel Morris, that last voice, was the commander of 3/5 Marines. Sangin had been a battleground long before Colonel Morris arrived. The British were there for four years, but could only fight the Taliban to a bloody stalemate. Now, the British were leaving. Darkhorse Battalion moved in.

Morris' orders were clear. Eliminate the Taliban as a threat.

MORRIS: The fight, initially, was to be able to maneuver outside of your patrol base without getting shot or stepping on an IED that had been planted 50 yards or 100 yards outside of the patrol base.

BOWMAN: It was mid-October 2010.

ASHLEY TAWNEY: We had to be there at 1 o'clock in the morning.

BOWMAN: Just a few weeks earlier, in California, it's before the mission started. The Marines gathered to say goodbye to their families in the middle of the night at the parade grounds at Camp Pendleton.

TAWNEY: The buses came, and we kind of waited around for awhile.

BOWMAN: Ashley Tawney was there with her husband, Sergeant Ian Tawney. Ashley and Ian had known each other since they were kids. Ashley was pregnant with their first child. Sangin was the fifth deployment for Sergeant Tawney. Ashley says this one felt different.

TAWNEY: I just remember driving in the car, and I would just kind of say, I just don't want you to go. And he's like, well, I'll be fine, you know, and I need to go and I want to go. And he always said, if you're on the varsity team, why sit on the bench?

BOWMAN: Sergeant Tawney had served in Iraq. Now, in Afghanistan, he would lead his own squad. They stood for hours that night at Pendleton. Then just before sunrise, it was time to say goodbye. Ashley Tawney kissed her husband.

TAWNEY: He said, I love you. And I just kind of like, nodded because I didn't want to like, start to cry by saying it.

BOWMAN: Sergeant Tawney boarded the bus that would take him to his plane for the long flight to Afghanistan.

(SOUNDBITE OF GUNSHOTS)

BOWMAN: A few weeks later, Sergeant Tawney led his men on a patrol.

(SOUNDBITE OF MEN TALKING)

BOWMAN: That was his voice. It's from a video sent home to Ashley. Here's what Tawney's patrol was up against: The Taliban had stockpiled arms poked holes in thick, mud walls to ambush the Marines. Sergeant Tawney had just a part of the

fight. For Colonel Morris, the Darkhorse commander, the battle was everywhere.

MORRIS: We had over a hundred firefights in the first three weeks. This is what we had trained for. The only thing that really was different from what we had trained all our lives for, as Marines, was the IED threat.

BOWMAN: IEDs, roadside bombs. On October 13th, four Marines from Darkhorse were killed when their vehicle was torn apart by a blast. The next day, some of Morris' Marines went out on a foot patrol.

MORRIS: The initial report came in that they were taking mortar fire.

BOWMAN: Here's what Colonel Morris remembers.

MORRIS: I mean, a rapid womf(ph), womf, womf of explosions. What it turned out to be was three guys stepping on IEDs in rapid succession.

BOWMAN: All three Marines were killed. In just two days, Morris lost seven of his men - more than his predecessor had lost in six months. And it didn't let up. At the end of the week, another Marine was dead - Sergeant Ian Tawney. He was 25.

TAWNEY: At our house we just bought, we had these - a lot of French doors, with windows in them.

BOWMAN: Ashley Tawney remembers waking up from a nap on her couch. Through the glass of the French doors, she watched two Marine officers pass by. She didn't have to open the door to see them standing there.

TAWNEY: And it was just a real solemn - just very eerie sight. And it's just like the movies. Just like the movies. And I just remember saying, oh, shit.
