This letter responds to your Freedom of Information Act (FOIA) request for "an electronic copy of the FOIA Case Log for AFTAC for the time period FY2005 and FY2006 and FY2007-to-date." Your request was received by this office on 28 Jun 07 and assigned case number 2007-0020-AFTAC. Your request for release of the subject document is partially denied.

A review was conducted by AFTAC's classification manager and controlled unclassified information manager. Information was found requiring continued protection in the interest of national security. Additionally the document contains FOR OFFICIAL USE ONLY information which if released would cause a foreseeable harm to an interest protected by the FOIA. Information is redacted and appropriate annotations made in redacted boxes.

As Commander, I am the original classification authority and the initial denial authority for the agency records requested. In consultation with my classification manager and controlled unclassified information manager, I have determined the requested document contains information which is currently and properly classified SECRET as defined in the AFTAC General Subjects Security Classification Guide, 11 January 2011, consistent with Executive Order 13526. The redacted information reveals classified processes and functions. Any unauthorized release could reasonably be expected to cause serious damage to the national security. All reasonably segregable portions are provided. Redacted information is denied pursuant to Title 5, United States Code (USC), Section 552(b)(1), national security information, and (b)(6), invasion of privacy.

FOIA Exemption 6, 5 U.S.C. § 552(b)(6), requires withholding of information in personnel, medical, and similar files where disclosure "would constitute a clearly unwarranted invasion of personal privacy." In applying Exemption 6 a balancing test must be done, weighing the privacy

interests of the individuals named in a document against the public interest in disclosure of the information requested. The public interest in disclosure is one that will "shed light on an agency's performance of its statutory duties." Dep't of Justice v. Reporters Committee, 489 U.S. 749, 773 (1989). Such information does not usually shed any light on the way the Air Force mission is carried out or how the Air Force performs its statutory functions.

You have the right to appeal my nondisclosure decision. If you elect to do so, write to the Secretary of the Air Force within 60 calendar days from the date of this response letter. It is very important that you include in your appeal request any additional reasons for reconsideration. Attach a copy of this letter and reference case number 2007-0020-AFTAC. Submit your appeal online at the Air Force Public Access Link, https://www.efoia.af.mil/palMain.aspx, or address your appeal letter to:

The FOIA provides for collection of fees based on the costs of processing a request. Consistent with information provided in your letter, we determined your fee category is "all others." You were provided the first two hours of search time and the first 100 pages at no cost. You do not pay review charges. Current chargeable fees are below program fee tolerances; therefore, fees associated with this request are not assessed.
