This letter is a final response to your April 23, 2012 Freedom of Information Act (FOIA) request for a copy of the weekly report to management on NNSA FOIA statistical information. Your request was received in our office on April 25, 2012.

I contacted the National Nuclear Security Administration's (NNSA) Office of the General Counsel (OGC) to search for responsive records. OGC located the following documents: CY11 Weekly FOIA Reports (Encl 1) and CY12 Weekly FOIA Reports (Encl 2). The documents are released to you with redactions pursuant to 5 USC §552(b)(6) (Exemption 6 of the FOIA). The justification for using Exemption 6 is described below.

The information withheld under Exemption 6 is names of living individuals whom records are being sought by another individual (3<sup>rd</sup> Party). The purpose of Exemption 6 is to protect "individuals from the injury and embarrassment that can result from the unnecessary disclosure of personal information." To determine whether disclosure would constitute a clearly unwarranted invasion of personal privacy, the public interest in disclosure, if any, must be balanced against the privacy interests that would be invaded by disclosure of the information. Since the release of the individual's name will not reveal anything of significance to the public, the interest in protecting against the invasion of privacy, which would result to the individuals in question, far outweighs the public interest in such disclosure.

In addition, it is widely held that federal employees have no expectation of privacy regarding their names, titles, grades, salaries, and duty stations. See 5 CFR, Part 293.311 (1994); Core v. United States Postal Serv., 730 F. 2d 946, 948 (4th Cir. 1984); National W. Life Ins. Co. v. United States, 512 F. Supp. 454, 461 (N.D. Tex. 1980). Therefore, the disclosure of such information about federal employees would involve little or no invasion of privacy. The Supreme Court has long found a privacy interest in the names of private individuals significant enough to warrant protection from disclosure under Exemption 6.

Pursuant to 10 CFR 1004.8, the denial of a FOIA or Privacy Act request may be appealed, in writing, within 30 days after receipt of a letter denying any portion of the request, to the Director, Office of Hearings and Appeals, Department of Energy, 1000 Independence Avenue, SW, Washington, DC 20585. The written appeal, including envelope, must clearly indicate that a Freedom of Information or Privacy Act appeal is being made, and the appeal must contain all other elements required by 10 CFR 1004.8. Judicial review will thereafter be available to you in the District of Columbia or in the district where: (1) you reside, (2) you have your principal place of business, or (3) the Department's records are situated.

Pursuant to 10 CFR §1004.7(b)(2), Ms. Elizabeth L. Osheim is the person responsible for the denial of the above mentioned information pursuant to Exemption 6 of the FOIA.

You may appeal our withholding of Exemption 6 information pursuant to 10 CFR, §1004.8. Such an appeal must be made in writing within 30 calendar days after receipt of this letter, addressed to the Director, Office of Hearings and Appeals, HG-1, U.S. Department of Energy, L'Enfant Plaza, 1000 Independence Avenue SW, Washington, DC 20585. Your appeal must contain a concise statement of the grounds for the appeal and a description of the relief sought. Please submit a copy of this letter with the appeal. Please clearly mark both the envelope and the letter "Freedom of Information Appeal". Thereafter, judicial review will be available to you in the District of Columbia or in the district where: (1) you reside; (2) you have your principal place of business; or (3) the Department's records are situated.
