This is a final response to your Freedom of Information Act (FOIA) request dated April 2, 2011, and received in this Office on April 13, 2011, for a copy of the Office of Information Policy's (OIP) tracking database that includes all open Freedom of Information Act, Privacy Act, Presidential Records Act and Mandatory Declassification Review requests in this Office. This response is made on behalf of OIP.

We have completed our search in OIP and four documents, totaling forty-six pages, have been located that are responsive to your request. These documents consist of four separate logs of requests from OIP's tracking database. I have determined that twenty-five pages are appropriate for release without excision. Also enclosed are twenty-two pages with excisions made pursuant to Exemption 6 of the FOIA, 5 U.S.C. § 552(b)(6), which pertains to information the release of which would constitute a clearly unwarranted invasion of the personal privacy of a third party. The withheld information consists of the names of individuals who have requested information on themselves or third parties cited in FOIA requests. None of the information being withheld is appropriate for discretionary disclosure. Please note that in accordance with Department regulations, the cut-off date for our searches was September 12, 2011. See 28 C.F.R. § 16.4(a) (2012). As such, this log contains requests that remained open in OIP's tracking system as of September 12, 2011; many of these requests have since been closed.

The information contained in these logs include the request number, analyst initials, requester name, requester organization, date request was initially received, track, and the subject. In some entries, information in the original logs was entered incorrectly; in such instances we have corrected the entry for accuracy.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. *See* 5 U.S.C. 552(c) (2006 & Supp. IV 2010). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.




