RE: Request for Information, FOIA Request No. 12-10709

This is in response to your Freedom of Information Act request for "The number of BOP inmates identified as transvestite, cross dresser or sex change (as noted in BOP Directive 5040.05, excluding names and other identifying information)".

In response to your request we are providing the Gender Identification Disorder list. All names and register numbers of the inmates were redacted. The release of this information could reasonably be expected to constitute an unwarranted invasion of the personal privacy of third parties and also possibly endanger the life of an individual. The statutory basis for this withholding is 5 U.S.C. \$552 (b) (7) (C), (b) (7) (F) and (b) (6).

Exemption (b) (7) (C) exempts from disclosure records or information compiled for law enforcement purposes which would constitute a clearly unwarranted invasion of personal privacy surrounding other individuals.

Exemption (b)(7)(F) provides for the withholding of records or information compiled for law enforcement purposes which could endanger the lives or physical safety of an individual.

Exemption (b)(6) exempts personnel and medical files and similar files, when the disclosure of such information would constitute a clearly unwarranted invasion of personal privacy.

Also, the program statement (5040.05) you reference in your request is no longer in use and the terminology used in 1998 in that program statement has since changed. The Gender Identification Disorder list provided is the most responsive to your request.

Pursuant to 28 C.F.R. §16.9, this denial may be appealed to the Attorney General by filing a written appeal within sixty days of the date of the letter denying your request. The appeal should be addressed to the Office of Information and Policy, U.S. Department of Justice, 1425 New York Ave., NW, Suite 11050, Washington, D.C. 20530. Both the envelope and the letter of appeal itself must be clearly marked: "Freedom of Information Act Appeal."

I trust this has been responsive to your request.
