Re: Freedom of Information Act (FOIA) Request 2013-4747

This is in response to your May 9 FOIA request for a copy of the FOIA Log from April 1, 2013 to the present.

A search of the FOIA Tracking System was performed by our office. Enclosed is a copy of the log of all requests received between April 1-13, 2013 (date of search).

Exemption 6 protects information contained in personnel, medical, and similar files, the disclosure of which would constitute a clearly unwarranted of personal privacy. We have determined that the public interest, if any, in disclosing an individual's name, address, and certificate number on some of the records is outweighed by the privacy interest. This information has been redacted and is being withheld from disclosure under Exemption 6 (5 U.S.C. 552(b)(6)).

If you owe fees for the processing of this request, an invoice containing the amount due and payment instructions will be enclosed with this letter.

The undersigned is responsible for this partial denial determination. You may request an administrative review of this determination by writing to the Assistant Administrator for Finance and Management (AFN-140), Federal Aviation Administration, 800 Independence Avenue SW, Washington, DC 20591. Your request for reconsideration must be made in writing within 30 days from the receipt of this letter and must include all information and arguments relied upon. Your letter must state that it is an appeal of the above determination regarding a request made under the FOIA, and the envelope containing the appeal should be marked "FOIA Appeal."
