We do not have many communications with the Governor or the Governor's Office. The bulk of them are emails and related materials pertaining to the ARRC's president and CEO Pat Gamble's recent trip to China to appear at a rail conference and meet with various people regarding coal development. Dear Ms. Bockman:

As Ethics Supervisor for the Alaska Railroad I have carefully gone over each of the anonymous allegations presented in the referenced letter. To summarize, the allegations are:

- 1.) **(a)** hiring is unethical.
- 2.) **definition** hiring is unethical.
- 3.) Cronyism exists in management hiring.
- 4.) The railroad is in bad financial straits and is spending unnecessarily on bond payments, and on a project called "collision avoidance."
- 5.) The Railroad is unnecessarily buying four locomotives.

Most of the fault for the alleged unethical actions on the part of the railroad is placed on for nearly seven years

seven years.

I will address the allegations in order:

- **Example** I personally sought out and approved use of the **Constant** to facilitate a badly needed wholesale cultural change to our railroad safety program. They are a leading transportation industry safety consultant. They have assisted us over the past five years nearly a dozen times. Results are incontrovertible. The past four years have seen us successively set the best ever safety statistics.
- Directors for several years, serving in the position (required by ARCA statute) of

> the Board member with "ten years of railroad management experience." When his Board term was up, I personally asked him to remain on with us as a technical and safety consultant. Since we have no one in the company with his broad experience and expertise, his trusted advice over the past five years on safety, locomotive purchases, freight car utilization and maintenance has been invaluable to corporate decision making. He is widely regarded by labor and management alike for his technical knowledge and his ability to work well with employees. He remains an important part of the Alaska Railroad team.

- Cronyism. This is a common allegation that I have handled a few times before, . usually from disgruntled union employees. The pattern is familiar. They typically lobby for all Alaskan hiring, all promotions to be from within the corporation, and less corporate management. I personally watch this guite carefully. Out of our nearly 800 employees, we average about 90% Alaskan hire. Because there are no other railroads in Alaska, promotions naturally predominate from within. That said, a certain "freshness" and new experience is needed from the outside. The Burlington Northern Santa Fe (BNSF) is one of the two largest United States railroads in the lower 48. Of the 180 management hires we have made during the past 7 years, only 8 have come from BNSF. As for hiring spouses, that is not unusual at all. The Alaska Railroad has always had, of necessity, a higher percentage of extended family participation than typically found in the lower 48, mostly on the union employee side. In the ARRC, there are 17 employed couples, as well as 11 occurrences where both parents and their children are working for ARRC. I do not have a problem with that if they are qualified applicants. I also make sure they do not supervise one another.
- Poor Financial Shape. Our anonymous writer obviously has not taken the time to assess the corporation through the use of annual financial reports, which are a public document and published on our website as well. This allegation simply falls apart in light of audited reporting data, sent each year directly to our legislature (by law). Regarding unwise spending, both the Railroad Board and the Legislature approved the bonds in question in 2006 and the proceeds are now at work rebuilding several hundred miles of badly worn rail and ties left over from Federal ownerships' deferred maintenance. "Collision avoidance" (CAS) is also being partially funded by the bond proceeds. It is an emerging technology based train control program. CAS is the number one implementation priority for United States railroads on the National Transportation Safety Board (NTSB) list of safety priorities, and has been for several years. We will implement CAS within two years ... more than likely the first railroad in the country to do so. Besides the sale of bonds and the expenditure of bond funds on capital projects being approved by the ARRC Board of Directors on an item by item basis, they continue to follow progress every two weeks in my written financial update reports, and every six weeks in our public Board meetings. Employees and the public are welcome to become informed at our Board meetings.

> <u>Four Unnecessary Locomotives</u>. In 2003 I personally petitioned Senator Stevens in a meeting in Washington, D.C. for locomotives and flat cars to accommodate the growth in train capacity ARRC needed to meet the Department of Defense (DOD) Stryker Brigade requirements. We are taking delivery of that equipment at the present time, funded by DOD.

To summarize, I have personal detailed knowledge of almost all these alleged "disgusting ethics." The additional data I collected (some contained within) where I did not already have detailed personal knowledge revealed nothing close to what the allegations stated were the unexaggerated "truth." In fact, every one of the allegations were totally and completely baseless ... more like pure fabrications. Considering that, and lacking any other evidence whatsoever, I chose not to pursue further the remaining claim that there has been some sort of "cozy arrangement" ethical breech on the part of Mr.

Dear Governor Palin:

On November 13, 2007, the Alaska Railroad Board of Directors adopted the enclosed resolution recommending amendments to the National Historic Preservation Act. It is important for me to provide you with some background on this action.

Certain elements of the National Historic Preservation Act are being interpreted by state historic preservation officers nationwide, including Alaska, to support or even require designation of an entire operating railroad corridor as eligible for inclusion on the National Register of Historic Places. The Alaska Railroad is deeply concerned that designation of the entire Alaska Railroad corridor could severely hamper our operations, delay necessary projects and maintenance, and be problematic and costly in many other ways.

We have joined railroads and railroad organizations throughout the country in the effort to revise federal law in order to protect operating railroads and our essential transportation infrastructure.

We are also working on a state solution with Deputy Commissioners Marty Rutherford and Dick LeFebvre in the Department of Natural Resources. In addition we have briefed Commissioner Tom Irwin on the matter. Your staff has been extremely helpful in recognizing the challenge we face and committed to working with us and the Alaska State Historic Preservation Office in finding a mutually acceptable solution that will complement any federal resolution.

Resolution No. 2007-63

Relating to the State Historic Preservation (SHPO)

WHEREAS, the Alaska Railroad is owned by the State of Alaska and provides essential year-round passenger and freight transportation services to both the citizens of the State and visitors to Alaska; and

WHEREAS, the Alaska Railroad was built by the U.S. Government for economic development of the Territory of Alaska and was purchased by the State of Alaska in 1985 to ensure its continued viability as an important tool for the economic growth and development of the State and to allow the continued use and future expansion of its right-of-way as a vital transportation corridor into rich mineral resource areas; and

WHEREAS, certain elements of the National Historic Preservation Act are being interpreted by state historic preservation officers nationwide, including in Alaska, to support or even require designation of an entire operating railroad corridor as eligible for inclusion on the National Register of Historic Places; and

WHEREAS, the Alaska Railroad is an active and independently managed State-owned business enterprise whose operations would be severely hampered if the entire Alaska Railroad were designated as, or deemed eligible for inclusion on the National Register as, an "historic district"; and

WHEREAS, no other operating railroad in the nation has been declared to be "historic" on a system-wide basis, with the possible exception of small tourist and historic sightseeing railroads that are ineligible for Federal Transit Administration funds; and

WHEREAS, the Alaska Railroad has always supported, and continues to support, the historic designation of key individual elements of the railroad, such as historic depots, bridges, and other unique facilities for inclusion on the National Register of Historic Places.

NOW, THEREFORE, BE IT RESOLVED by the Alaska Railroad Board of Directors that:

1. The Alaska Railroad strongly opposes any attempt to designate the entire Alaska Railroad as "historic" under the National Historic Preservation Act.

2. The Alaska Railroad supports a revision to the federal legislation to clarify that only certain particularly important elements of railroads, and not entire operating corridors, warrant consideration for eligibility on the National Register of Historic Places.

3. A copy of this resolution shall be provided to Alaska's Congressional delegation, the Governor of the State of Alaska, the Commissioner of the Alaska Department of Natural Resources, and such other persons as may be appropriate.

Please find enclosed the Annual Disclosure Statement of Alaska Railroad Corporation Chairman John Binkley, which is submitted to you as the Governor's Designated Ethics Supervisor (DES) for members of state boards and commissions. Because this is the first time you will have seen this particular form, we thought some background information would be helpful to you.

As you know, the Alaska Railroad Corporation (ARRC) was created to take over ownership and operation of the Alaska Railroad upon purchase by the State of Alaska from the U.S. in 1985. ARRC employees are not employees of the State, and the Alaska Railroad Corporation Act originally exempted ARRC employees from all provisions of Alaska Statutes (AS) Title 39. It did, however, impose conflict-of-interest standards on board members and also required the corporation to adopt a code of ethics for directors and employees substantially equivalent to that contained in AS 39. The corporation did so, adopting Board Rule 6 in May 1985 and several personnel rules over the years. Then, in the 1998 legislative session, the statutes were amended to subject both ARRC employees and directors to the provisions of the Executive Branch Ethics Act, AS 39.52. The change became effective on January 1, 1999. For ARRC employees, the ARRC President and CEO is the DES. For Board members, the Board chairman is the DES, and for the Board Chairman, of course, you are the DES. Please find enclosed the Annual Disclosure Statement of Alaska Railroad Corporation Chairman John Binkley, which is submitted to you as the Governor's Designated Ethics Supervisor (DES) for members of state boards and commissions. Because this is the first time you will have seen this particular form, we thought some background information would be helpful to you.

As you know, the Alaska Railroad Corporation (ARRC) was created to take over ownership and operation of the Alaska Railroad upon purchase by the State of Alaska from the U.S. in 1985. ARRC employees are not employees of the State, and the Alaska Railroad Corporation Act originally exempted ARRC employees from all provisions of Alaska Statutes (AS) Title 39. It did, however, impose conflict-of-interest standards on board members and also required the corporation to adopt a code of ethics for directors and employees substantially equivalent to that contained in AS 39. The corporation did so, adopting Board Rule 6 in May 1985 and several personnel rules over the years. Then, in the 1998 legislative session, the statutes were amended to subject both ARRC employees and directors to the provisions of the Executive Branch Ethics Act, AS 39.52. The change became effective on January 1, 1999. For ARRC employees, the ARRC President and CEO is the DES. For Board members, the Board chairman is the DES, and for the Board Chairman, of course, you are the DES.
