This is the final response to your Freedom of Information Act request dated December 26, 2005, for access to "a copy of the contents of the administrative tracking folder associated with the June 30, 2005, FOIA request on various subjects from Congressman John Conyers and the committee on the Judiciary and his colleagues." You additionally requested "any emails, records, notes, memos, correspondence, interoffice materials, etc. associated with the processing of this request." I apologize for the delay which resulted in the need to consult with other Department of Defense components and agencies.

In our letter dated February 10, 2006, we advised you that additional documents were still being processed within the Office of the Secretary of Defense. We have now completed the review of all responsive material. Mr. Michael Reheuser, an Initial Denial Authority for the Office of the General Counsel, has determined that 24 pages in their entirety are exempt from release pursuant to 5 U.S.C. § 552(b)(5), which applies to attorney-client communications and attorney work-product deliberative and predecisional privilege, and 5 U.S.C. § 552(b)(6), which pertains to information the release of which would constitute a clearly unwarranted invasion of the personal privacy of third parties.

I have determined that portions of the enclosed documents are also exempt from release pursuant to 5 U.S.C. §§ 552(b)(5) and (b)(6). Additional redacted information is being withheld pursuant to 5 U.S.C. § 552(b)(2), which pertains to purely internal agency practices. The remaining information is being withheld pursuant to 5 U.S.C. § 552(b)(3) which pertains to information exempt from release by statute. In this instance, the following statutes apply: 10 U.S.C. § 130(b), which permits the withholding of personally identifying information regarding DoD personnel in overseas, sensitive, or routinely deployable units; 10 U.S.C. § 424, which permits the withholding of organizational and personnel information for the National Reconnaissance Office and Defense Intelligence Agency; and 5 U.S.C. § 574, which permits the withholding of dispute resolution communication between a neutral and a party to the dispute.

If you are not satisfied with this action, you may submit an administrative appeal to James Hogan, Chief, Policy, Appeals and Litigation Branch, Office of Freedom of Information, 1155 Defense Pentagon, Washington, D.C. 20301-1155. Your appeal should be postmarked within 60 calendar days of the date of this letter, should cite to case number 06-F-0687, and should be clearly marked "Freedom of Information Act Appeal." There are no fees associated with this response in this instance.



I checked with both of the POCs to whom I sent the search estimate request for that FOIA request from members of Congress.

One POC (from the SIGINT Directorate) is out in class through Friday. So I will have to see if I can coordinate SID's response with someone else in her office and get back to you on that portion.

The other POC (the SIGINT reports database office), gave me an estimate of \$445.76. Her search would require two hours at the professional rate of \$44/hr. and two hours of machine search on Anchory. Anchory costs are \$178.88/hr. So it's \$88 for a person and \$357.76 for a machine. What we do in our estimates back to requesters is give them the total (\$445.76) and deduct their two free hours (\$88) and quote them the difference (\$357.76) as their assessable fees.

I will email you again, as soon as I have the SID response.
