This is in response to your Freedom of Information Act (FOIA) request dated November 17, 2004, that was received in this office on November 24, 2004, and assigned FOIA case number 05-HQ-34. Please reference this number in any future correspondence you may have regarding this case. In your request you asked for the following:

"Please provide a list of FOIA requests to your agency from 1999 through to November 12, 2004. Your response should indicate what was requested and whether the request was denied, including what grounds the request was denied (including, but not limited to specific FOIA exemptions, information labeled Critical Infrastructure Information (CII), Sensitive Security Information (SSI), etc."

Enclosed please find redacted copies of our current FOIA Access control log and other FOIA control logs utilized from October 2000 through December 2004. No records were found for the 1999 FOIA control log. While the enclosed control logs contain some of the information you requested, they do not contain all of the information specified in your request. As you are aware, a record must exist and be in the possession and control of the Department of Defense at the time of the search to be considered subject to the FOIA. Therefore, we are not obligated to create, compile, or obtain a record to satisfy a FOIA request.

We redacted personal information on these control logs that if released, it would result in a clearly unwarranted invasion of personal privacy. This information is considered exempt under FOIA exemption 6, 5 U.S.C. 552 (b) (6), and there is no discretion in its release. Information contained in these logs that was not responsive to your request was also deleted. We have waived the copy fees for the enclosed documents as the fees were less than \$15.00.

If you consider the above determination to be adverse, you may appeal it in writing, within 60 calendar days of the date of this letter. Any such appeal should include any reasons for reconsideration that you wish to present. Your appeal should be addressed as follows, and sent to Mr. Edward A. 
