
This is the final response to your letter dated November 10, 2007, which was received by the Council on Environmental Quality ("CEQ") on December 28, 2007. In your letter, you requested electronic copies of CEQ FOIA case logs for the time period FY 2005 to the present.

A search of CEQ's records system has been conducted. At this time we are releasing three (3) documents totaling eleven (11) pages in their entirety. These Microsoft Word tables, compiled in preparation for our annual report to the Department of Justice, summarize CEQ's FOIA requests for the fiscal years you requested. Information includes the name of the requester, the date CEQ received the request, the date the request was closed out, CEQ's response time, and disposition decisions.

CEQ's annual FOIA reports from 1998 through 2007 are available on our website at <http://www.whitehouse.ceq.foia.html>. Our most recent report, *Annual Report 2007*, was posted on February 1, 2008.
