I am writing in response to your October 21, 2007 Freedom of Information Act (FOIA) request to the Committee for Purchase From People Who Are Blind or Severely Disabled (Committee). You requested a copy of the FOIA Case Log for the years 2005 through the present. You requested that the subject matter field be included, Privacy Act requests be omitted, and that we make every attempt to respond to you by December 31, 2007.

I have decided to grant your request in full. Documents in our possession and responsive to your request are enclosed. We have withheld a log entry, pursuant to FOIA Exemption 6, 5 U.S.C. 552 (b)(6) and the Privacy Act of 1974 5 U.S.C. 552a, as the request was for the requester's personnel records. Not only was this information submitted to the Committee as a Privacy Act request, but its release would constitute an invasion of personal privacy.

In accordance with our regulations, 41 CFR 51-8.14(b) and (c), we have waived the fee for processing your FOIA request.
