This is in response to your May 26, 2007 letter relating your Freedom of Information Act (FOIA) request for copies of the Office of Inspector General's FOIA logs for FY 2006 and FY 2007 to present.

We have reviewed these logs under the terms of FOIA, and have determined that portions of each log must be withheld pursuant to FOIA exemptions 6 and 7C. Exemption 6, 5 U.S.C. 552(b)(6), protects information in personnel, medical or similar files, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy. Exemption 7C, 5 U.S.C. 552 (b)(7)(C), protects information compiled for law enforcement purposes, the disclosure of which could reasonably be expected to constitute an unwarranted invasion of personal privacy.

Enclosed are copies of the FOIA logs for FY 2006 and FY 2007 to present, with the relevant redactions noted.

Your administrative appeal rights are explained in Appendix A, should you wish to request a review of this partial denial. If you have any questions, please contact Mary Offerdahl of my staff at (202) 482-0242.

APPENDIX A
