This letter responds to your Freedom of Information Act (FOIA) request concerning a FOIA case log for the Environment and Natural Resources Division (ENRD) of the Department of Justice for FY2005, FY 2006, and FY2007 to-date. ENRD received your request on August 16, 2007.

Please find enclosed a disk containing one document. We have redacted this document in part pursuant to Exemption 2, which exempts from mandatory disclosure records that are "related solely to the internal personnel rules and practices of an agency." 5 U.S.C. 552 (b)(2). Additionally, redactions are made under Exemption 6 of the FOIA, 5 U.S.C. § 552(b)(6), which relates to information about individuals in "personnel and medical files and similar files" where the disclosure of such information "would constitute a clearly unwarranted invasion of personal privacy," and Exemption 7(C) of the FOIA, 5 U.S.C. § 552(b)(7)(C), which relates to law enforcement records that "could reasonably be expected to constitute an unwarranted invasion of personal privacy."

This determination may be appealed within sixty days of the date of this letter by writing to the Co-Director, Office of Information and Privacy, U.S. Department of Justice, 1425 New York Ave., NW, Suite 11050, Washington, DC 20530-0001. You should clearly mark your envelope and letter: "Freedom of Information Appeal." See 28 C.F.R. 16.9(a) and 5 U.S.C. 552(a)(6)(A).
