- 1. January 4, 1999: list of "Impact credit card holders," and staff directory Disposition: requested items provided January 8, 1999
- 2. January 10, 1999: copy of "Department of States Treaties and other International Agreements", address of General Counsel of the Department of Defense, and "information on how the Foreign Claims Settlement Commission works."

Disposition: On January 21, 1999, requested address provided, along with copy of most recent Yearbook of the Foreign Claims Settlement Commission. Provision of copy of Treaties and International Agreements deferred pending receipt of advance payment to cover copying charges, which were estimated to be over \$3,000.00.

3. January 20, 1999: "any and all materials for the entire file that [the Foreign Claims Settlement Commission] ...has compiled to this date relating to" the requester.

Disposition: On January 22, 1999, advised the requester that a search of the records of the Commission disclosed existence of no document, file or other material of any kind under his name or otherwise pertaining to him.

4. January 25, 1999: "list of all persons assigned a GSA 'SmartPay', 'IMPAC', or other Visa or MasterCard."

Disposition: On January 28, 1999, names of personnel furnished to requester.

5. February 1, 1999: "1998 FOIA Case Log" and "copy of most recent memo or report on the status of the current backlog of outstanding FOIA requests."

Disposition: On February 10, 1999, requester was advised that no such log exists, because small number of FOIA requests received made maintenance of a log unnecessary, but a list of FOIA requests was furnished to requester; requester was also advised that no backlog report or memo available because no backlog existed.

6. February 15, 1999: Copies of five specific FOIA requests and of Commission responses thereto.

Disposition: On February 22, 1999, requested copies, with private information redacted, furnished to requester.

7. February 9, 1999: Names of Commission personnel responsible for computers systems and related software, libraries, training and purchasing.

Disposition: On February 12, 1999, name furnished to requester.

8. February 25, 1999: Names, office addresses and phone and fax numbers of "IMPAC Cardholders."

Disposition: On March 1, 1999, requested information furnished to requester.

9. February 28, 1999: (1) "statistical reports or other reports summarizing the operations of the Holocaust Survivors Claims Program;" (2) meeting minutes or other meeting report of the non-exempt portions of the July 1998 meeting held on the subject that was mentioned in the Federal Register;" (3) "copies of any email . . .at the FCSC concerning the [Holocaust Survivors Claims Program in 1998 or 1999 to date."

Disposition: On March 11, 1999, furnished copies of Commission Yearbooks for 1995, 1996, and 1997, and a press release dating from June 1997, all of which contain some statistics; however, request for other statistics was denied under Exemption 3 of the FOIA. Copy of minutes of July 1998 meeting also furnished. No e-mail messages furnished, as none existed.

10. April 9, 1999: "Copies of any and all material that has [requester's] name on it."

Disposition: On April 13, 1999, requester was advised that no such document, file or other material could be found.

11. April 5, 1999: "Listing of the names, addresses, room numbers, cities, states and zip codes for all employees within your installation who have been issued, possess or who are authorized to purchase through a government credit card."

Disposition: On April 13, 1999, requested information furnished to requester.

12. June 11, 1999: "Access to and copies of any and all documentation in the possession of [the Foreign Claims Settlement Commission] referring to or relating to Thomas Jeffery Banks . . . [personal information deleted] and/or any of the following businesses that he operates, West African Safaris, Inc., Foundation for Field Research, and Lost World Trading Company."

Disposition: On June 21, 1999, requester was advised that no such documentation could be found.

13. July 1, 1999: "Any and all documents which would give the best details of death for the following Air America pilots (helicopter) KIA in Southeast Asia 1960-1975", the names of which were then listed.

Disposition: On July 8, 1999, requester was advised that no such documents could be found.

14. July 5, 1999: Copy of "FOIA Log" for 1998.

Disposition: On July 23, 1999, requester was advised that no such log exists, because small number of

requests received makes maintaining such a log unnecessary.

15. July 27, 1999: copy of the Commission's staff directory.

Disposition: On August 9, 1999, copy furnished to requester.

16. July 30, 1999: "all correspondence, inquiries and other information requested by or provided to First Lady Hillary Clinton from 1993 to present."

Disposition: On August 10, 1999, copies of three pieces of correspondence, with personal information deleted, furnished to requester.

17. July 21, 1999: "Any document that pertains, [in] whole or in part, to the relationship between Cuba, the European Union, including individual European states, and the United States. This request includes economic data on Cuba, any reports on the Cuban Democracy Act or the Helms-Burton Law, and lists, registers or compilations that would report on European activity in Cuba [and] any report, summary or speeches that would detail any activity in Cuba for the purposes of ascertaining Cuba's position related to the Helms-Burton law . . .from 1996 to the present."

Disposition: On August 11, 1999, copy of a report from the Federal Register furnished to requester, along with advice that no other pertinent document could be found.

18. September 10, 1999: "All information in [the Foreign Claims Settlement Commission's (FCSC's)] files with respect to the notice that was given to [the FCSC] regarding . . . claims [against Iraq before the United Nations Compensation Commission (UNCC)] and the efforts of [the FCSC] to disseminate [sic] these claims to Gulf War veterans and their families."

Disposition: On September 14, 1999, requester was advised that no such information existed, because the Commission had no connection to the UNCC.

- 19. Duplicate of 18. above, received through Justice Management Division.
- 20. October 1, 1999: Listing of Commission personnel who are "IMPACT (sic) Visa cardholders and Procurement Officers."

Disposition: On November 2, 1999, requested information furnished to requester.

21. November 1, 1999: Records under name of requester and under two identification numbers, and a claim form and information on the "claims process."

Disposition: On November 4, 1999, requester was advised that no such records could be found and no claim form was available because no claims programs were then in progress.

22. October 19, 1999 (received November 8, 1999): "Material regarding the Bravo thermonuclear test of Operation Castle performed by the United States in the Marshall Islands during the year 1954."

Disposition: On November 16, 1999, requester was advised that no such material could be found.

23. November 11, 1999: The Commission's "IMPAC credit card list."

Disposition: On November 16, 1999, requested information furnished to requester.

24. November 10, 1999 (received December 8, 1999): "All documents and tangible things" relating in various ways to a letter dated March 4, 1966, from Winthrop G. Brown, then-Ambassador of the United States to the Republic of Korea, addressed to the Minister of Foreign Affairs of the Republic of Korea.

Disposition: On December 8, 1999, requester was advised that no such document or tangible thing could be found.

25. December 4, 1999: Records and information on various named individuals.

Disposition: On December 9, 1999, requester was advised that one exchange of correspondence between the Commission and one of the named individuals was found, but that without the individual's consent, disclosure had to be denied, based on Exemption 6 of the FOIA.

26. November 9, 1999 (received December 17, 1999): (1) "A copy of the documentation that [the Commission] is bound by, describing a 'foreign claim' and the process for submitting a 'foreign claim' with [the Commission]"; and (2) "A copy of any and all documentation with [the requester's] name/numbers as entered on the attached personal data sheet."

Disposition: On December 17, 1999, requester was furnished another copy of the Commission's most recent Yearbook, and was advised that no documentation of the type described in the second part of his request could be found.

- 1. January 1, 2000: "Agency guide for requesting information under the FOIA and PA." Disposition: requested items provided January 11, 2000
- 2. January 18 and 19, 2000: "1) A complete 1999 FOIA case log; 2) Any records that contain the 'name' (sic) and mail location of the 'Alien Property Custodian;' 3) Any records that contain the 'name' (sic) and mail location of the 'Secretary of the Treasury;' and 4) Any records that contain the 'name' (sic) and mail location of the Solicitor General."

Disposition: On January 24, 2000, requester was advised that Commission does not maintain FOIA case logs, and that the "Alien Property Custodian" office was abolished many years ago; addresses of the Secretary of the Treasury and Solicitor General were furnished to requester.

3. January 24, 2000: Names and e-mail addresses of Commission employees in various Civil Service Occupational Series.

Disposition: On February 3, 2000, requested information was furnished to requester.

4. January 28, 2000: Information on the Alien Property Custodian and copies of the Freedom of Information Act requests received by the Foreign Claims Settlement Commission during calendar year 1999.

Disposition: On February 7, 2000, requester was advised to contact the Office of Foreign Litigation in the Department of Justice concerning matters relating to the former Alien Property Custodian, and was furnished appropriately reducted copies of the 1999 FOIA requests received by the Commission.

5. January 18, 2000: Copies of "any correspondence between [the Commission] and the United States Senate office of former Senator Bill Bradley."

Disposition: On February 23, 2000, requester was furnished appropriately redacted copies of requested material.

6. January 24, 2000: Copies of various materials described in the FOIA and in the Commission's FOIA regulations.

Disposition: On February 7, 2000, requester was advised that copies of Commission's "current index" would cost more than \$250 and that advance payment would therefore be required; copy of Commission's CFR-published regulations furnished to requester.

- 7. February 17, 2000: "Redacted copies of the Freedom of Information Act (FOIA) requests received by the Foreign Claims Settlement Commission during calendar year 1998, "all' FOIA information" related to a FOIA request dated December 4, 1999, . . . and for the complete mailing location of the Office of Foreign Litigation and Freedom of Information officer in charge."
- Disposition: On March 16, 2000, appropriately redacted copies of FOIA requests furnished to requester; for request for address, requester was referred to previous Commission response.
- 8. February 23, 2000: Copies of "all correspondence, inquiries and other information requested by

Congressman James Maloney of Connecticut from January 1997to the present."

Disposition: On March 20, 2000, requester was advised that no such correspondence, inquiries or information could be found.

9. March 17, 2000: "Iinformation relating to [requester's] financial records, which are more clearly described as denial of payment as follows: Office of Personnel Management's Revolving Fund and Expenses Accounts".

Disposition: On March 28, 2000, requester was advised that no such information could be found.

- 10. February 16, 2000: "All claims indexes which cover the [Commission's] twelve claims programs." Disposition: On March 6, 2000, requester was advised that copies of the indexes would cost more than \$250 and that advance payment would therefore be required.
- 11. March 22, 2000: Listing of the names and telephone numbers of Commission employees who are credit card holders.

Disposition: On March 31, 2000, requested information furnished to requester.

12. March 9, 2000 (received April 23, 2000): Copies of "all files, records, statements, ontelligence [sic] materials, documents, memorandum, transcripts of tape recordings, or any other wire or telephonic communication, and all photographs kept and maintained under [requester's] name or under any aliases used or assigned by [the Foreign Claims Settlement Commission] or known to [it], as kept by [the Commission] or any office under [its] control or supervision, and any files [it has] knowledge of that identify [the requester] or any alias.

Disposition: On April 24, 2000, requester was advised that no such files, records or other materials could be found.

13. March 28, 2000 received April 19, 2000): Copy of the Commission Annual FOIA/PA Report to Congress.

Disposition: On April 24, 2000, requester was advised that no such report exists because the Commission's FOIA/PA reporting to Congress is done by the Department of Justice, and that requester should therefore contact the Department directly.

- 14. May 10, 2000: Copy of list of IMPAC card holders employed by the Commission. Disposition: On May 16, 2000, requested information was furnished to requester.
- 15. May 25, 2000: Copy of the Commission's personnel directory. Disposition: On May 30, 2000, requested document was furnished to requester.
- 16. May 31, 2000: Copy of the Foreign Claims Settlement Commission's "Freedom of Information Case Log" "[f]or the time period September 1, 1998 to the present," and for a copy of the Commission's "Freedom of Information Appeal Log" for that time period.

Disposition: On June 8, 2000, requester was advised that no such logs are maintained by the Commission because of the small number of FOIA requests and appeals received.

- 17. June 2, 2000: Copies of "any records from [this] Commission generated on [requester's] former FOIA/PA request, appeal or [requester's] U.S. District Court of Columbia case vs. Dept. of Treasury . . . in which [this] Commission is defendant or any of [its] records otherwise related to [requester]. Disposition: On June 9, 2000, copies of requester's appeal and Office of Information and Privacy's response, already in her possession, were furnished to requester; requester was advised that no other pertinent records could be found.
- 18. June 12, 2000: Copies of "all documents containing information regarding . . . Walter Tribe being electronically tortured for over six years non-stop to see how much torment a man can take before he finally breaks down and lashes out at society. Any information pertinent to the contents of http://www.winwally.com or http://www.psychwar.com or http://www.lapdwatch.com or http://www.sirwally.com or http://www.psychwar.net. . . .

Disposition: On June 16, 2000, requester was advised that no such document or information could be found.

19. June 16, 2000: Copies of "all records and/or data contained in [the Foreign Claims Settlement Commission's] "system of records", records and/or files concerning [requester's] Appellation, Jack-Wade: Warren/Jack: Warren and/or under the misnomer (sic) "name"/cestui que trust, JACK WADE WARREN/JACK WARREN created by the government for resembling (sic) [requester's] Appellation and/or identifiers concerning [requester].

Disposition: On June 26, 2000, requester was advised that no such records or information could be found.

20. July 10, 2000: Copies of "all records and/or data contained in [the Foreign Claims Settlement Commission's] "system of records", records and/or files concerning [requester's] Appellation, Dennis-Eugene: Cordes/Dennis: Cordes and/or under the misnomer (sic) "name"/cestui que trust, DENNIS EUGENE CORDES/DENNIS CORDES created by the government for resembling (sic) [requester's] Appellation and/or other identifiers concerning [requester].

Disposition: On July 21, 2000, requester was advised that no such records or information could be found.

- 21. July 24, 2000: Copies of "all documents and information [the Foreign Claims Settlement Commission has] concerning "the Franciscan Order (O.F.M.)(a/k/a First Order of Franciscans) and College of San Girolamo," "IOR, a/k/a Vatican Bank, a/k/a Institute odf Religious Works, a/k/a Instituto per le Opere di Religione," [and] "Ustasha Treasury; Vatican Gold."
- Disposition: On July 31, 2000, requester was advised that no such documents or information could be found.
- 22. July 26, 2000: Copies of "all documents and materials electronic, paper or otherwise that are in

any way, shape or form related to communications, meetings or other dealings between [the Foreign Claims Settlement Commission] and any of the following individuals and entities: Richard B. "Dick" Cheney; Halliburton Co.; any Halliburton employees or representatives; any Halliburton subsidiaries or affiliates; or any of those entities' employees or representatives . . . produced since February 1993." Disposition: On July 31, 2000, requester was advised that no such documents or materials could be found.

- 23. July 10, 2000 (received August 1, 2000): Copies of "all records and/or data contained in [the Foreign Claims Settlement Commission's] "system of records", records and/or files concerning [requester's] Appellation, Tilmon-Rufus: Partin/Tilmon: Partin and/or under the misnomer (sic) "name"/cestui que trust, TILMON RUFUS PARTON/TILMON PARTIN created by the government for resembling (sic) [requester's] Appellation and/or other identifiers concerning [requester]. Disposition: On August 3, 2000, requester was advised that no such records or information could be found.
- 24. August 9, 2000: "Opening dates of businesses, insurance coverage plan on how and when reinbursement [sic] is made," with respect to seven named restaurant businesses in Beaumont, Jasper, and Silsbee, Texas.

Disposition: On August 16, 2000, requester was advised that no such information could be found.

25. August 9, 2000: Listing of the names, addresses and telephone numbers of the Commission's IMPAC purchase card holders.

Disposition: On August 14, 2000, the requested information was furnished to the requester.

- 26. August 14, 2000: "Copies of any and all correspondence, including but not limited to letters, faxes and email (including attachments and enclosures) [the Foreign Claims Settlement Commission] has received from vice presidential candidate Senator Joseph Lieberman (CT) and/or members of his staff from January 1, 1994 to present along with [the Commission's] responses." Disposition: On August 18, 2000, the requested materials were furnished to the requester.
- 27. August 14, 2000: Copies of files and records related to claims of the Gillette Company and the Gillette Safety Razor Company, claims of their German subsidiaries Roth Buechner G.m.b.H. and Gillette Safety Razor Company G.m.b.H., Berlin, claims of their Polish subsidiary "Grom" Fabryka Przyborow do Golenia, Spolka z.o.o., and copies of all FOIA requests made to the Foreign Claims Settlement Commission in 1998, 1999, and 2000.

Disposition: On August 8, 2000, requested materials were furnished to the requester, except for the copies requested from a file in one completed claims program, the files in which have since been transferred to the National Archives and are no longer accessible by the Commission.

28. October 2, 2000: "Copies of all information maintained by [the Foreign Claims Settlement Commission that pertain to [the requester]," and "[r]eports regarding the Hon. Okla Jones, II

(deceased)."

Disposition: On October 10, 2000, requester was advised that no such information could be found.

29. October 5, 2000: Information on the Commission's FOIA office.

Disposition: On October 17, 2000, requested information was furnished to the requester.

- 30. October 18, 2000 (received October 23, 2000): Information from eleven categories of "records" on "Germans," Adolph Hitler, "terrorists," "Communism," former President Eisenhower, L. Ron Hubbard, and [requester's "civil cases . . .in U.S. District Court Columbia [sic]." Disposition: On November 9, 2000, request was declined on grounds that it was insufficiently specific.
- 31. November 15, 2000: Names of Commission employees who are credit card holders. Disposition: On November 15, 2000, the requested information was furnished to the requester.
- 32. July 27, 2000, and September 1, 2000 (received December 8, 2000): "Records and files . . . concerning child torture cases, land deeds., citizenship status, any information on American Affairs Task Force on Detroit Police Dept., work status."

Disposition: On December 13, 2000, requester was advised that no such records or files could be found.

- 33. December 15, 2000: Copies of various Commission administrative documents, including its telephone list, organization chart, and Annual Report to Congress. Disposition: On December 21, 2000, requested documents were furnished to requester.
- 34. December 12, 2000: List of make and model numbers of certain listed office equipment used by the Commission.

Disposition: On December 22, 2000, requester was advised that the Commission does not use any of the types, models or makes of office equipment on the requester's list.

1. January 17, 2001: "[A]ny and/or all correspondence, documents, electronic mail, records, reports, and/or other information-bearing materials . . . sent, transmitted, mailed, shipped and/or forwarded" to or from the Foreign Claims Settlement Commission by or to U.S. Representative Maxine Waters and/or employees of her Congressional offices and/or her political campaign committees between January 1, 1998, and December 31, 2000, inclusive.

Disposition: On January 23, 2001, requester was advised that no such correspondence or other material could be found.

- 2. October 18, 2000 (further reply) Information on "1. Germans acting as spies, terrorists, or communist leaders in Eastern European countries.
- 2. The death of Adolph Hitler in 1945
- 3. Former President Dwight Eisenhower
- 4. L. Ron Hubbard, founder of the Church of Scientology
- 5. Civil actions involving [requester]."

Disposition: On January 26, 2001, requester was advised that no such information could be found.

- 3. March 12, 2001: Duplicate of FOIA request of March 28, 2000 (received April 19, 2000). Disposition: Copy of reply of April 24, 2000, forwarded to requester.
- 4. March 10, 2001: Request for certain "other specified documents," for records under the names of, or otherwise relating to, Frank S. Ang, Edward Cellini, Brian Glerum, Sharon Ang, and Elizabeth Ang DeLisle, and for answers to three questions relating to telephone calls, a telephone number, and one Frank Redeker.

Disposition: On April 4, 2001, requester was advised that no such document, record, or other material or information could be found.

- 5. March 4, 2001 (received March 12, 2001): "All records maintained by [the Foreign Claims Settlement Commission] pertaining to and/or captioned: [requester], Towers Perrin Forster and Crosby (TFP&C), Cresap McCormick and Paget (CMP), and Ernst & Young LLP (E&Y). Disposition: On April 4, 2001, requester was advised that no such records could be found.
- 6. May 7, 2001: "Copy of any and all 'comity agreement(s)' of the Foreign Claims Settlement Commission," a "copy of all recent Memoranda of Understanding (MOU's) in the FCSC . . . signed, renewed or implemented since 1992," and a "copy of any agency procedural materials concerning the procedures for the establishment of or methods of approving comity agreements or Memoranda of Understanding in the FCSC."

Disposition: On May 21, 2001, requester was advised that no such documents or other materials could be found.

7. June 4, 2001: Request for various FOIA/PA and other correspondence logs. Disposition: On June 19, 2001, requester was advised that no such logs exist.

8. June 4, 2001 (received June 28, 2001: "Copies of all records relating to requests to the U.S. Department of Justice ("DOJ") for waiver of search fees, submitted by requesters claiming news organization status, from 1990 to the present[,] . . . including the requests, all correspondence between DOJ and the requester concerning such requests, any appeals of denials of such requests and all correspondence with the requesters concerning such appeals."

Disposition: On July 3, 2001, requested copies were furnished to requester.

- 9. May 8, 2001 (received July 9, 2001): Copy of the Foreign Claims Settlement Commission's "Annual FOIA/PA Report to Congress for the years 1970 to 1980." Disposition: On July 16, 2001, requester was advised that no such reports could be found.
- 10. July 9, 2001: "Access to all correspondence between, and all other public documents that may be filed with, the Foreign Claims Settlement Commission of the Department of Justice and any of the following" which consisted of a list of twenty-six individuals and entities identified in one way or another with the name "Bloomberg," plus the "Johns Hopkins University."

 Disposition: On July 23, 2001, requester was advised that no such correspondence or other documents.

Disposition: On July 23, 2001, requester was advised that no such correspondence or other documents could be found.

11. June 15, 2001 (received July 24, 2001: "Information about the occupations of the . . . Foreign Claims Settlement Commission."

Disposition: On August 6, 2001, the requested information was furnished to the requester.

- 12. August 6, 2001: Names and e-mail addresses of IMPAC credit card holders. Disposition: On August 17, 2001m, the requested information was furnished to the requester.
- 13. July 23, 2001(received July 31, 2001): Copies of FOIA requests received from the requester in 1999 and 2000 and of the Commission's responses thereto.

Disposition: On August 30, 2001, the requested materials were furnished to the requester.

- 14. April 10, 2001 (received October 5, 2001): "Correspondence and other information requested by or provided to the following Members of the House of Representatives and United States Senate between January 1, 1995, and March 31, 2001[:] Rep. Greg Ganske [and] Sen. Tom Harkin." Disposition: On October 9, 2001, the requested materials and information were furnished to the requester.
- 15. November 2, 2001: Information "with respect to any deposits in excess of \$24,999.99, which were deposited on behalf of non-individuals (i.e., businesses, other governmental agencies, etc.) that remain in the Unclaimed Moneys Account."

Disposition: On November 2,2001, requester was advised that no such information could be found.

1. January 4, 2002: Copy of the Foreign Claims Settlement Commission's "Freedom of Information Act Case Log for the time period October 1, 2000 through the present."

Disposition: On January 7, 2002, requester was advised that no such case log exists.

2. January 10, 2002: Copies of FOIA requests and Commission responses thereto from October 1, 2000, to present.

Disposition: On January 25, 2002, the requested copies were furnished to the requester.

3. February 4, 2002: "Access to and copies of all documents relating to any Florida aspects of the Commission's investigation into the terrorist attacks of Sept. 11 as well as the anthrax investigation in South Florida."

Disposition: On February 4, 2002, requester was advised that no such documents could be found.
