I write on behalf of the Professional Responsibility Advisory Office (PRAO) to respond to your Freedom of Information Act request dated October 9, 2007, and received by this office on October 18, 2007. In that letter you request under the Freedom of Information Act (FOIA) “an electronic copy of the FOIA Case Logs for the DOJ PRAO for the time period FY 2005 and FY 2006 and FY 2007-to-date.”

Please find enclosed a compact disc containing an electronic copy of our FOIA log covering FY 2005, FY 2006 and FY 2007 to date. The CD contains a tab delimited text file containing the Year, Date Received, Requester, Summary, and PRAO Response fields from the PRAO FOIA log database. Pursuant to Exemption (b)(2) of the FOIA, 5 U.S.C. § 552, which pertains to information related to purely internal agency practices, the following fields are withheld from the production: FOIA Number, Date Response Due, Date Responded, Response Days, Time Spent, Expedited Request, and Expedited Granted.

Per your request letter, PRAO did not include first party requests in the provided file. Additionally, the names of private individuals named in third party requests are redacted from the summary field in several records.

If you are not satisfied with the action on your request, you may administratively appeal by writing to the Co-Director, Office of Information and Privacy, United States Department of Justice, Flag Building, Suite 570, Washington, D.C. 20530-0001, within sixty days from the date of this letter. Both the letter and the envelope should be clearly marked "Freedom of Information Act Appeal."
