The United States Marshals Service (USMS) is responding to your request for a copy of the USMS Freedom of Information Act Case Log for the time period for Fiscal Year 2005 to 2007.


Pursuant to your request, the USMS conducted a search of its files and located 66 pages of documents responsive to your request. We have determined to grant you access to these documents, except for the names and other information pertaining to government employees and/or third-party individuals, and techniques or procedures referenced therein, which are exempt from disclosure pursuant to exemptions 6 and 7(E) of the Freedom of Information Act (FOIA), 5 U.S.C. 552(b). Exemption 6 protects records or information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy. Exemption 7(E) protects records or information compiled for law enforcement purposes, to the extent that disclosure would disclose guidelines or techniques and procedures for law enforcement investigations or prosecutions, if such disclosure could reasonably be expected to risk circumvention of the law. Since you requested a digital copy of the log, the information is being released to you on a CD, which is enclosed.

If you are dissatisfied with my action on this request, you may appeal this partial denial within 60 days of the date of this letter by writing to the Director, Office of Information and Privacy, United States Department of Justice, Suite 11050, 1425 New York Avenue, NW, Washington, D.C. 20530-0001. Both the letter and the envelope should be clearly marked "Freedom of Information/ Privacy Act Appeal." In the event you are dissatisfied with the results of any such appeal, judicial review will thereafter be available to you in the United States District Court for the judicial district in which you reside or have your principal place of business, or in the District of Columbia.
