This responds to your letter of October 12, 2007, requesting information under the Freedom of Information Act (FOIA).

Specifically, you requested copies of the "FOIA Case Logs for the FTA for the time period FY2005 and FY2006 and FY2007-to-date."

A search of the FTA files has disclosed documents responsive to your request, which are enclosed. However, personal privacy information has been removed from the documents. We have based these deletions on Exemption 6 of the FOIA, USC § 552 (b)(6), as implemented by the Department of Transportation's regulations, 49 CFR § 7.13(c)(6), on the grounds that the release of this information would constitute a clearly unwarranted invasion of personal privacy.

The persons responsible for this determination are the undersigned and Linda Watkins Sorkin, an attorney with the Office of Chief Counsel.

To the extent that personal privacy information is being withheld, this is a partial denial of your request. If you are not satisfied with this response, you may appeal by writing to the Deputy Administrator of the Federal Transit Administration, 1200 New Jersey Avenue, S.E., East Building, 5<sup>th</sup> Floor, Washington, D.C. 20590. An appeal must be submitted within thirty (30) days after you have received this determination. It should contain any information and arguments you may wish to rely on, and the envelope in which the appeal is sent should be prominently marked "FOIA APPEAL." The Deputy Administrator's determination will be administratively final.

The duplication fee for these documents is negligible and is waived pursuant to the FOIA and the Department of Transportation regulations, 49 C.F.R. § 7.44 (c). I hope this information meets your needs.
