This is in response to your Freedom of Information Act (FOIA) request dated October 9, 2007. In your letter you requested "an <u>electronic</u> copy of the FOIA Case Logs for the Department of Labor OASAM [Office of the Assistant Secretary for Administration and Management] for the time period FY2005 and FY2006 and FY2007 to date."

We have prepared the enclosed file which includes data currently available in the Department's automated FOIA Tracking System. In those instances where the request is a first party request, we have redacted the name, account number or other personally identifiable information on the log in accordance with Exemption 6 of FOIA to protect the confidentiality of the individuals listed. Please note assignments in the FOIA Tracking System are made to multiple agencies in DOL.
