This responds to your Freedom of Information Act (FOIA) appeal in FOIA case number 2008-007.

In your initial FOIA request, you sought a copy of the FOIA case logs of the Bureau of Engraving and Printing (Bureau) for fiscal years 2004 through 2007. On October 26, 2007, the Bureau's Disclosure Officer, Mr. James Braun, sent you a list of FOIA cases for the relevant time period, which shows the name of the requestor, the FOIA number assigned to each case, and the deadline for responding to each request.

In your appeal to me, you indicate that the records you received are not responsive to your request because they do not include the field that describes the subject of each request. As an administrative remedy to your appeal, you have requested that I release the records with the subject field.

Although the term "FOIA case log" is subject to different interpretations, your FOIA request adequately conveys your intent that the records you seek should include the "subject of request" field. As a result, I am granting your appeal.

Please find enclosed the records that you requested from the Bureau's electronic FOIA database. In accordance with the provisions of your initial FOIA request, I am omitting all Privacy Act and "first party" requests.
