This responds to your Freedom of Information Act (FOIA) request dated July 29, 2007, received in this office on August 8, 2007, relating to:

“The Freedom of Information Act (FOIA) log maintained by the Department of the Interior. At a minimum, the log might be expected to include the ordinarily included fields, and certainly would include the “subject of request” field. The formatting is up to you but I ask that you include as many fields from the FOIA Log database as is practical, including any notes or other status or disposition information. However, I recognize that your FOIA Case Log may be nonstandard in format and I would appreciate any portions you can provide”

Responsive to your request we are providing you with a copy of the Bureau of Indian Affairs 2006/2007 FOIA logs, which we are enclosing with the following exceptions,

The names, allotment numbers, of the individuals have been deleted on each page, 1 through 160 of this material. The Department maintains that the individuals identified in the records have privacy interests in withholding this information. We do not perceive, nor have you enunciated, any public interest that would be served in disclosing this data, which would outweigh the privacy interests of the subject individuals. The release of the individuals' names, addresses, and social security numbers would be a violation of their privacy. Therefore, we are withholding this information under exemption 6 of the FOIA (5 U.S.C. § 552 (b)(6) which permits an agency to withhold “personnel and medical files and similar files the disclosure of which would constitute a clearly unwarranted invasion of personal privacy.”

The fee for processing of this request before taking your fee category into account, would have been \$39.40.

is below the Departmental threshold for charging. Therefore, there is no chargeable fee for the processing of this request.


