Exemption 6 exempts from disclosure information about "individuals" in "personnel and medical files and similar files" when the disclosure of such information "would constitute a clearly unwarranted invasion of personal privacy." There is no charge for this record since it is NASA/KSC's policy not to assess fees totaling less than \$15.00.

Since portions of the records have been withheld, you have a right to appeal to the NASA Administrator, if you are dissatisfied with this response. The appeal must reference this FOIA #2008-023 and (1) be addressed to the Administrator, National Aeronautics & Space Administration (NASA), Mail Stop P, 300 E. Street SW, Washington, DC 20546; (2) be clearly identified on the envelope and in the letter as an "Appeal under the Freedom of Information Act;" (3) include a copy of the request for agency record and a copy of this initial determination; (4) to the extent possible, state the reasons why you believe this determination should be reversed; and (5) be sent to the Administrator within 30 calendar days of the date of receipt of this initial determination.
