

FROM 5 U.S.C. SECTION 552(b)

- #4 Information that is classified as trade secrets and/or of commercial or financial value obtained from a person and is privileged or a confidential source of information.
- #5 Inter-agency or intra-agency memorandums or letters which would not be available by law to a party other than an agency in litigation with the Agency.
- #6 This exclusion is intended to exclude from disclosure all personal and medical files, and all private or personal information contained in other files which, if disclosed to the public, would amount to a clearly unwarranted invasion of the privacy of any person, including members of the family of the person to whom the information pertains.
- #7 Information contained in investigatory files compiled for law enforcement purposes except to the extent available by law to a party other than an agency.
- #7(C) Information pertaining to the privacy interests of individuals, including information about an individual which he could reasonably assert an option to withhold from the public at large because of its intimacy or its possible adverse effect upon himself or his family.
- #7(D) The identification of a confidential source or confidential information furnished by a confidential source.
