This is in response to your FOIA request (U-2007-42), dated 4 June 2007, which was referred to our office from the Ramstein FOIA Office (435 CS/SCSIR) on 19 June 2007. You requested a copy of the FOIA Case Log for the USAFE office from fiscal year 2002-2007 (to date – 19 June 2007).

Our Agency conducted a thorough legal review of the responsive documents and we have determined the documents are partially releasable. The responsive documents include twenty one pages of information and none of the pages were completely denied, however, the blackened out portions are exempt from release pursuant to the following:

DOD 5400.7/AF Sup, Chapter 3, Exemption 6 and United States Code, Title 5, Section 552 (b)(6) protects information in personnel and medical files, as well as similar personal information in other files, that, if disclosed to a requester, other than the person about whom the information is about, would result in a clearly unwarranted invasion of personal privacy. Release of information about an individual contained in a Privacy Act System of records that would constitute a clearly unwarranted invasion of personal privacy is prohibited.

DOD 5400.7/AF Sup, Chapter 3, Exemption 7(c) and United States Code, Title 5, Section 552 (b)(7)(c) provides for the protection of personal information in law enforcement records, the disclosure of which "could reasonably be expected to constitute an unwarranted invasion of personal privacy."

Should you decide to appeal the information that is exempt from release, you may write to the Secretary of the Air Force within 60 calendar days from the date of this letter. Include in the appeal your reasons for reconsideration and attach a copy of this letter. Address your letter as follows:
