Pursuant to Department of Energy (DOE) regulations implementing the FOIA, 10 C.F.R. 1004.5(b), I am the DOE official responsible for making the initial determination with regard to the disclosure of the information you requested.

Our Response

Your request for documentation regarding the FOIA Case Logs for the Golden Field Office is granted in part and denied in part. Because the total number of pages responsive to your request is below your benchmark of 150 (for which you requested advance notification prior to proceeding), we have proceeded with processing your request.

We are providing the enclosed FOIA log sheets for the DOE Golden Field Office as you requested. You will note that they include the name of the requester, date of the request, date received, requester type, a summary description of the request, close out data, and expenses (if applicable).

We are unable to provide the responsive documents in electronic or digital copy because although the database is electronic, the records are extracted in paper copy. Your FOIA request also asked that the records include the addresses and phone numbers of the requesters. The Golden Field Office does not include addresses and phone numbers of the requesters when logging the request into our FOIA database. The Freedom of Information Act does not require government agencies to prepare documents where none previously existed, so we are unable to provide this information.
