

This record is being released to you in full, except that we are withholding certain personal information such as the names and personal e-mail addresses of several private individuals referenced in certain FOIA requests, as release of this information would constitute a clearly unwarranted invasion of personal privacy under 5 U.S.C. 552(b)(6) and 49 C.F.R. 7.13(c)(6). In addition, we are redacting all information pertaining to several first party requests, in accordance with the instructions in your request. Please be advised that no fees have been assessed in connection with your request.

Pursuant to 49 C.F.R. 7.21, you have the right to appeal our decision to withhold the information referenced above to Ms. Patricia A. Prosperi, FHWA Associate Administrator for Administration. Should you wish to appeal, her decision will be administratively final. Your appeal must be made in writing within 30 days after receipt of this letter and must include all information and arguments relied upon in making the appeal. 


