This responds to your November 17 information request which was received on November 24 and assigned the above-referenced tracking number for processing under the Freedom of Information and Privacy Acts and related Departmental rules. 5 U.S.C. §§ 552-552a; 28 CFR § 16.1, <u>et seq</u>.

You requested "a list of FOIA requests to your agency from 1999 through to November 12, 2004. . . . [and] indicate what was requested and whether the request was denied, including what grounds the request was denied (including, but not limited to specific FOIA exemptions, information labeled Critical Infrastructure Information (CII), Sensitive Security Information (SSI), etc.)." This letter confirms that during a telephone conversation on December 16, 2004, between you and this Office's FOIA/Privacy Counsel, you were informed that the FOIA log maintained by this Office for the requested time period indicates the date each FOIA was received by this office, the subject of each request, and each requester's name. You were also informed that you can access the Department's Annual FOIA Reports on the Department's web site at http://www.usdoj.gov/04foia/04_6.html.

The processing of your information request has been completed and responsive documents are attached. This Office's FOIA log contains 51 pages of responsive documents covering the period you requested from year 1999 through November 2004. Following legal review by this Office under the Freedom of Information and Privacy Acts, the accompanying records have been deemed appropriate for release and are thus enclosed in their entirety, except for certain portions that have been redacted pursuant to FOIA Exemption 6.½

Along with your FOIA request, you also requested a waiver of all costs pursuant to 5 U.S.C. § 552(a)(4)(A)(iii). We did not make a determination on your fee waiver request at this time because we are assessing no search fees for 45 minutes of search time and 51 pages of duplication, pursuant to the Department of Justice FOIA rules, which provide that – "[e]xcept for requesters seeking records for a commercial use" – no charge shall be made for the first two hours of search time or the first 100 pages of duplication, and "[w]henever a total fee . . . is \$14.00 or less . . . , no fee will be charged" (28 CFR § 16.11(d)), although we reserve the right to reassess and aggregate fees for any subsequent searches in accordance with the governing regulations.

Since this completes our work upon your request, we are closing our file in this Office. This constitutes our final agency action in this matter.²/


